The presentation provided an overview of the York Regional Police (YRP) partnerships within the community, an outline of YRP supported charities, major fundraising initiatives, and major events held by YRP. In 2024, YRP executed 65 special events which wholly fundraised over 1.2 million dollars for partner agencies. Police Appreciation night is one of YRP's major fundraising events running for the last 29 years, and has fundraised over 1 million dollars over the past two years.
