

APPENDIX A – CHANGES IN CRIME STATISTICS

JANUARY – JUNE (2019 - 2020)

TOTAL CRIMINAL & FEDERAL VIOLATIONS

18,096 **Criminal & Federal Violations** were reported between January and June, 2020 compared to 19,609 during the corresponding period in 2019. This represents a decrease of 1,513 violations or 7.7 percent. The crime rate per 100,000 population for the first six months of 2020 was 1,495.84 compared to 1,637.28 during the corresponding period in 2019. This represents a decrease of 8.6 percent.

CRIMES AGAINST PERSONS

4,148 **Crimes Against Persons** (violent crime) violations were reported between January and June, 2020 compared to 4,376 during the corresponding period in 2019. This represents a decrease of 228 violations or 5.2 percent. The violent crime rate per 100,000 population during the first six months of 2020 was 342.88 compared to 365.38 during the corresponding period in 2019. This represents a decrease of 6.2 percent.

2 **Violations Causing Death** (Homicide and Criminal Negligence Cause Death) were reported in the first six months of 2020, compared to 7 during the corresponding period in 2019. Based on the rate of Violations Causing Death per 100,000 population, there has been a decrease of 71.7 percent.

13 **Attempt Capital Crime** violations were reported in the first six months of 2020, compared to 9 during the corresponding period in 2019. This represents an increase of 4 violations or 44.4 percent. Based on the rate of Attempt Capital Crime violations per 100,000 population, there has been an increase of 43.0 percent.

298 **Sexual Violations** were reported in the first six months of 2020, compared to 409 during the corresponding period in 2019. This represents a decrease of 111 violations or 27.1 percent. Based on the rate of Sexual Violations per 100,000 population, there has been a decrease of 27.9 percent.

15 **Commodification of Sexual Activity** violations were reported in the first six months of 2020, compared to 17 during the corresponding period of 2019. This represents a decrease of 2 violations or 11.8 percent. Based on the rate of Commodification of Sexual Activity per 100,000 population, there has been a decrease of 12.6 percent.

2,110 **Assault** violations were reported in the first six months of 2020, compared to 2,206 during the corresponding period in 2019. This represents a decrease of 96 violations or 4.4 percent. Based on the rate of Assault violations per 100,000 population, there has been a decrease of 5.3 percent.

91 **Violations of Deprivation of Freedom** were reported in the first six months of 2020, compared to the same number of violations during the corresponding period in 2019. Based on the rate of Violations Deprivation Freedom violations per 100,000 population, there has been a decrease of 1.0 percent.

1,619 **Other Violent Violations (formally Robbery & Other Violent Violations)** were reported in the first six months of 2020, compared to 1,637 during the corresponding period in 2019. This represents a decrease of 18 violations or 1.1 percent. Based on the rate of Other Violent Violations per 100,000 population, there has been a decrease of 2.1 percent.

CRIMES AGAINST PROPERTY

10,534 **Crimes Against Property** (property crime) violations were reported in the first six months of 2020, compared to 12,001 during the corresponding period in 2019. This represents a decrease of 1,467 violations or 12.2 percent. Based on the rate of Crime Against Property per 100,000 population, there has been a decrease of 13.1 percent.

857 **Break & Enter** violations were reported in the first six months of 2020, compared to 1,134 during the corresponding period in 2019. This represents a decrease of 277 violations or 24.4 percent. Based on the rate of Break & Enter per 100,000 population, there has been a decrease of 25.2 percent.

832 **Theft Over \$5,000** violations were reported in the first six months of 2020, compared to 753 during the corresponding period in 2019. This represents an increase of 79 violations or 10.5 percent. Based on the rate of Theft Over \$5,000 per 100,000 population, there has been an increase of 9.4 percent.

4,003 **Theft Under \$5000** violations were reported in the first six months of 2020, compared to 4,870 during the corresponding period in 2019. This represents a decrease of 867 violations or 17.8 percent. Based on the rate of Theft Under \$5000 per 100,000 population, there has been a decrease of 18.6 percent.

735 **Have Stolen Goods** violations were reported in the first six months of 2020, compared to 1,156 during the corresponding period in 2019. This represents a decrease of 421 violations or 36.4 percent. Based on the rate of Have Stolen Goods per 100,000 population, there has been a decrease of 37.1 percent.

2,642 **Fraud** violations were reported in the first six months of 2020, compared to 2,512 during the corresponding period in 2019. This represents an increase of 130 violations or 5.2 percent. Based on the rate of Fraud per 100,000 population, there has been an increase of 4.1 percent.

1,419 **Mischief** violations were reported in the first six months of 2020, compared to 1,545 during the corresponding period in 2019. This represents a decrease of 126 violations or 8.2 percent. Based on the rate of Mischief per 100,000 population, there has been a decrease of 9.1 percent.

OTHER CRIMINAL CODE

2,376 **Other Criminal Code** violations were reported in the first six months of 2020, compared to 2,366 during the corresponding period in 2019. This represents an increase of 10 violations or 0.4 percent. Based on the rate of Other Criminal Code violations per 100,000 population, there has been a decrease of 0.6 percent.

WEAPONS VIOLATIONS

263 **Weapons** violations were reported in the first six months of 2020, compared to 260 during the corresponding period in 2019. This represents an increase of 3 violations or 1.2 percent. Based on the rate of Weapons violations per 100,000 population, there has been an increase of 0.1 percent.

FEDERAL VIOLATIONS

729 **Drug Violations** were reported in the first six months of 2020, compared to 490 during the corresponding period in 2019. This represents an increase of 239 violations or 48.8 percent. Based on the rate of Drug violations per 100,000 population, there has been an increase of 47.3 percent.

44 **Other Federal Violations** were reported in the first six months of 2020, compared to 109 during the corresponding period in 2019. This represents a decrease of 65 violations or 59.6 percent. Based on the rate of Other Federal Violations per 100,000 population, there has been a decrease of 60.0 percent.

TRAFFIC VIOLATIONS

1,974 **Criminal Traffic** violations were reported in the first six months of 2020, compared to 2,541 during the corresponding period in 2019. This represents a decrease of 567 violations or 22.3 percent. Based on the rate of Criminal Traffic violations per 100,000 population, there has been a decrease of 23.1 percent.

550 **Impaired Operation** violations were reported in the first six months of 2020, compared to 653 during the corresponding period in 2019. This represents a decrease of 103 violations or 15.8 percent. Based on the rate of Impaired Operation violations per 100,000 population, there has been a decrease of 16.6 percent.

229 **Dangerous Operation** violations were reported in the first six months of 2020, compared to 193 during the corresponding period in 2019. This represents an increase of 36 violations or 18.7 percent. Based on the rate of Dangerous Operation violations per 100,000 population, there has been an increase of 17.5 percent.

8 **Fatal Collisions** occurred on our roadways in the first six months of 2020, compared to 9 during the corresponding period in 2019. This represents a decrease of 1 collision or 11.1 percent.

9 **Persons Died** on our roadways in the first six months of 2020, compared to same number 9 during the corresponding period in 2019.

CLEARANCE RATE

The **Clearance Rate** for Total Criminal and Federal Violations (excluding Traffic) decreased to 51.8 percent in the first six months of 2020 from 53.0 percent during the corresponding period in 2019. The clearance rate for Crimes Against Persons decreased 3.0 percent, for Property Crimes decreased 3.2 percent, for Other Criminal Code violations decreased 0.6 percent, for Drug violations increased 1.5 percent, and for Traffic violations increased 9.0 percent.

YOUTH CRIME

The **Youth Crime** rate per 1,000 youth population decreased to 4.94 (by 48.3 percent) in the first six months of 2020, compared to 9.55 in 2019. The number of youth involved in criminal incidents (formally charged and processed by other means) decreased to 489 (by 48.3 percent) in 2020 compared to 945 in 2019. The number of young persons charged decreased 36.3 percent and the number of youth processed by other means decreased 53.5 percent.

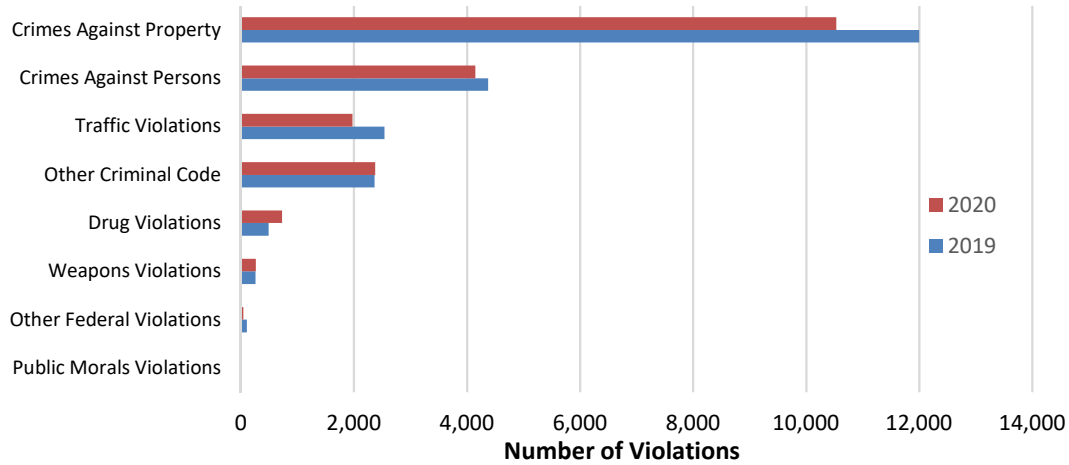

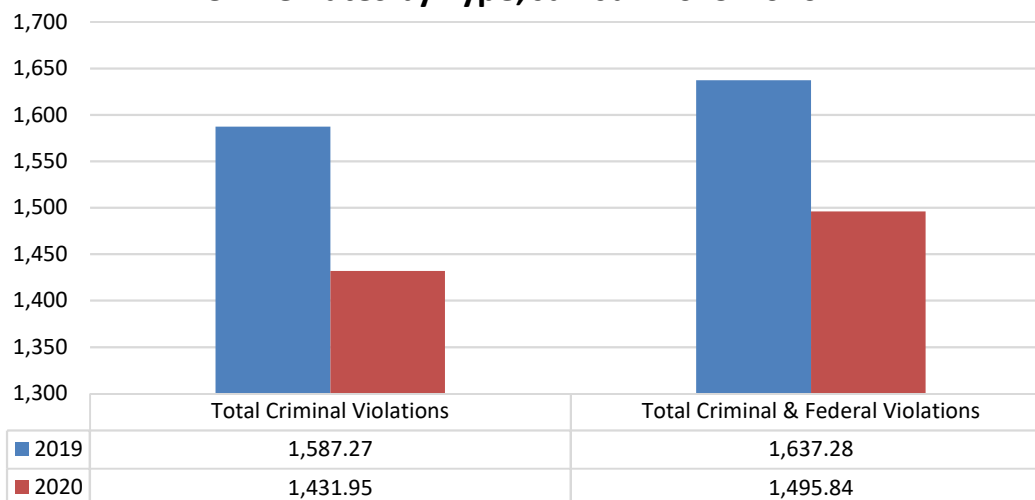
Violations by Crime Type, Jan-Jun 2019-2020

Crime Rates by Type, Jan-Jun 2019-2020

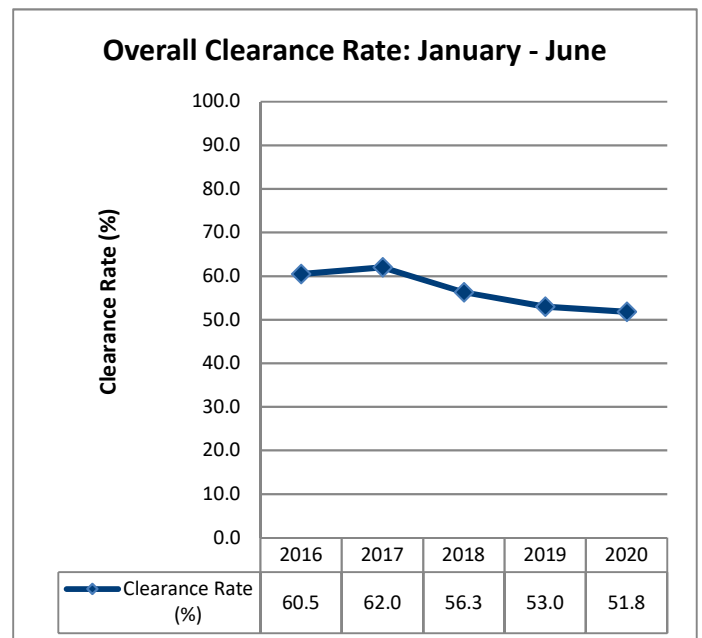
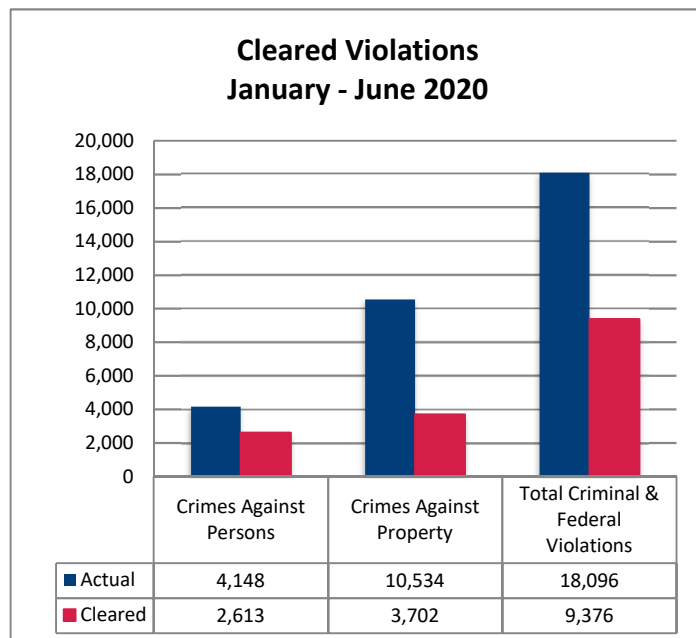

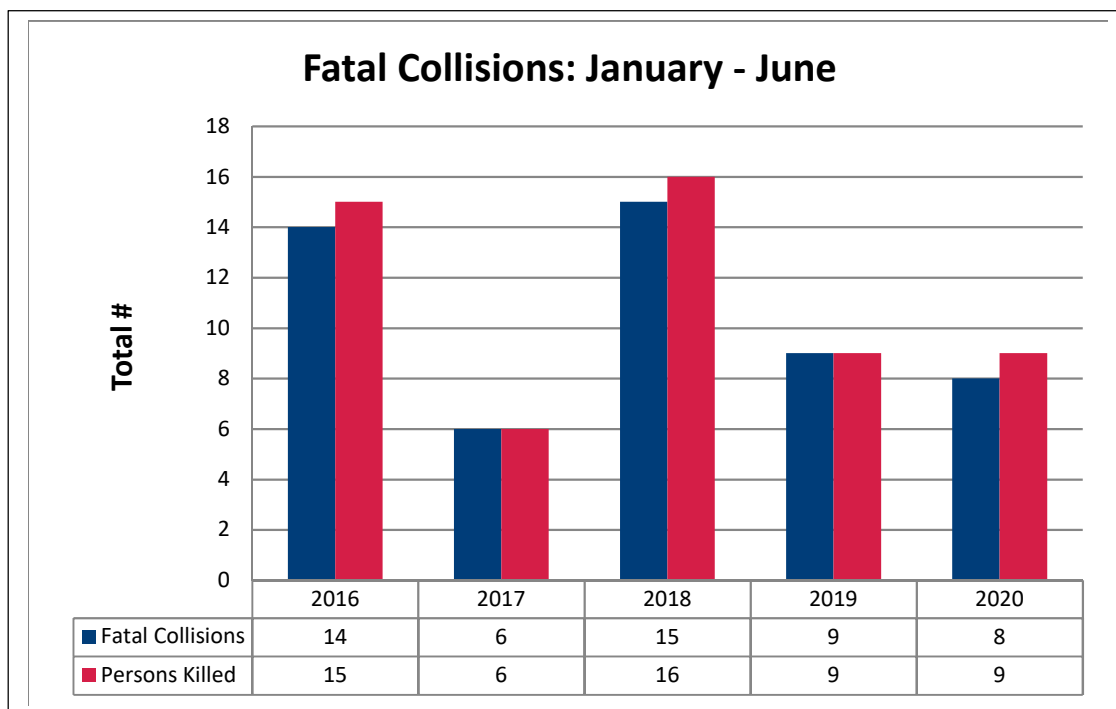

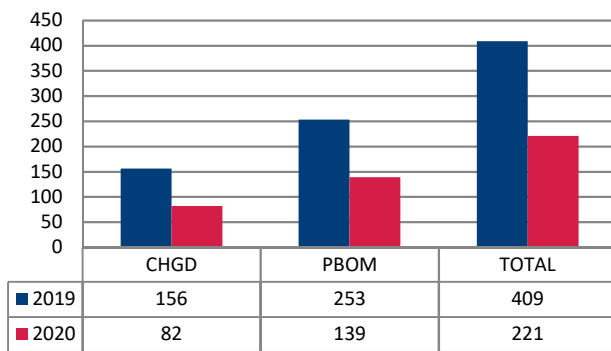

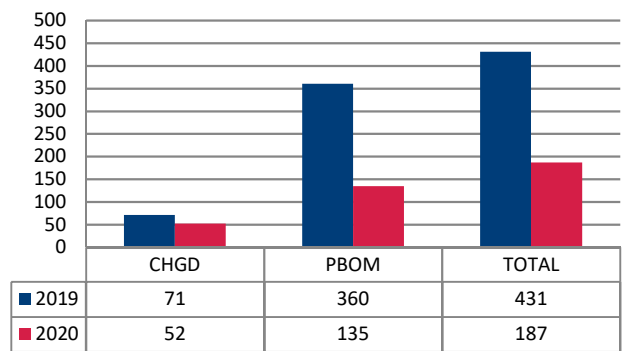

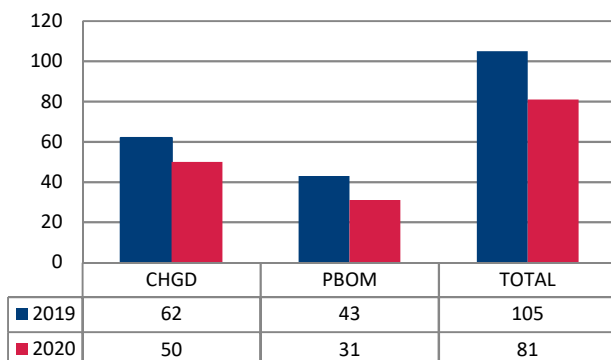
VIOLENT CRIME: January - June



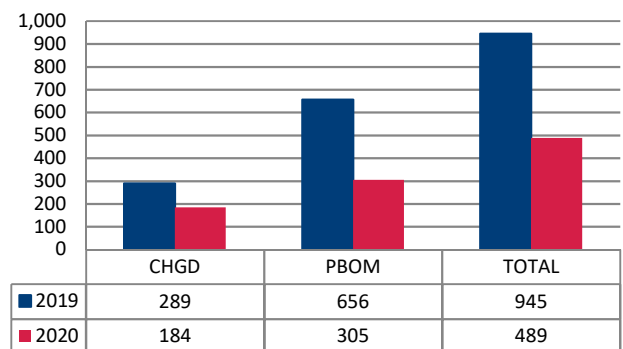
PROPERTY CRIME: January - June

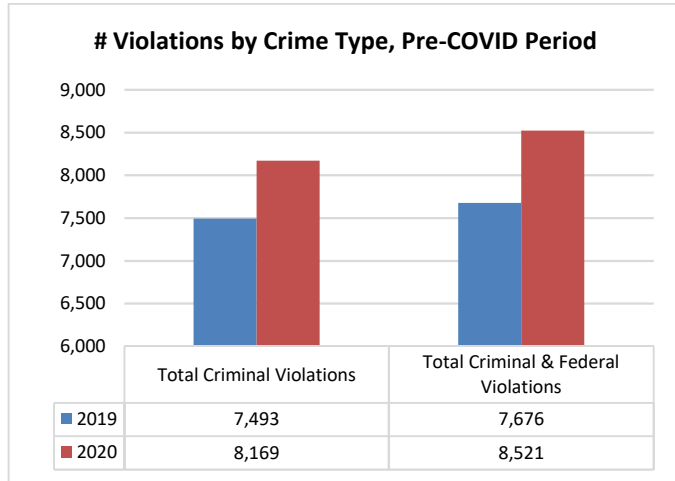

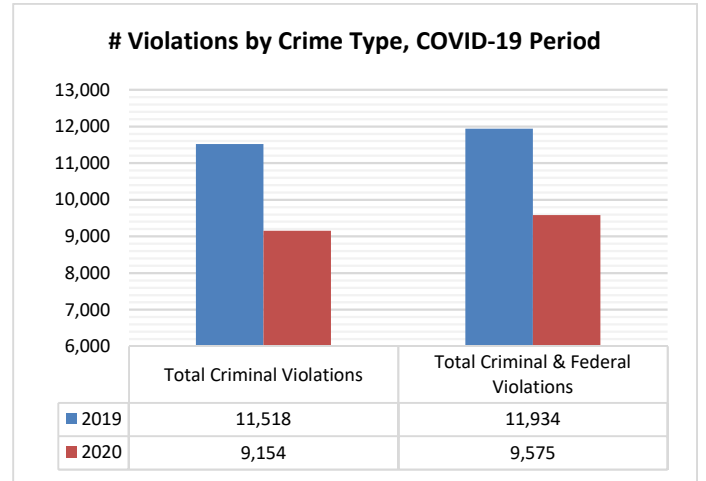
