SRO's in schools The Black community perspective

"Is the issue of SRO's in school more important than Black students?"

If Black parents and students tell you they want police-free schools, listen.

Why do Mayor's feel that the Black community is asking for something unthinkable?

"But the YRP does some amazing work. I've seen the programs."

Why is the Black community made to feel unreasonable? Why are we the villains for wanting to save our children?"

When the oppressed tell the oppressor, we are oppressed, listen.

Police in Schools began when funding was dispersed to Police Departments

Regardless of the good, consider all the bad

We don't know if there will come a time when the tide changes, leadership changes and we don't have "nice officers" in schools. It is not worth the risk

What could the funding be used for instead? (community programs back to Black organizations to undertake the work, social workers, and youth workers to undertake the work, promotion of Black organizations doing the work)

Responding to anti-Black Hate Crime

Equitable practices across York Region

What are the stats? Documentation?

2006 – 34% of reported hate crimes incited against Black community

2005 data showed a 30% increase from 2002

What are the latest statistics?

How is hate-crime dealt with across the Region?

Community advocates written record (What is our role?)

Why are Mayors not hearing about anti-Black racism as well as anti-Semitism?

We are on the front-lines of every social determinant of health and well-being

Annual report – Vanguard Project (gender equity)

Partnering

We need a community body that offers formalized services for hate incident victims and a program that formally documents incidents of hate in York Region (Canada).
