

APPENDIX A – CHANGES IN CRIME STATISTICS

JANUARY – JUNE (2020 - 2021)

TOTAL CRIMINAL & FEDERAL VIOLATIONS

18,345 **Criminal & Federal Violations** were reported between January and June, 2021 compared to 18,096 during the corresponding period in 2020. This represents an increase of 249 violations or 1.4 percent. The crime rate per 100,000 population for the first six months of 2021 was 1,501.90 compared to 1,495.84 during the corresponding period in 2020. This represents an increase of 0.4 percent.

CRIMES AGAINST PERSONS

4,485 **Crimes Against Persons** (violent crime) violations were reported between January and June, 2021 compared to 4,148 during the corresponding period in 2020. This represents an increase of 337 violations or 8.1 percent. The violent crime rate per 100,000 population during the first six months of 2021 was 367.19 compared to 342.88 during the corresponding period in 2020. This represents an increase of 7.1 percent.

6 **Violations Causing Death** (Homicide and Criminal Negligence Cause Death) were reported in the first six months of 2021, compared to 2 during the corresponding period in 2020. Based on the rate of Violations Causing Death per 100,000 population, there has been an increase of 197.1 percent.

19 **Attempt Capital Crime** violations were reported in the first six months of 2021, compared to 13 during the corresponding period in 2020. This represents an increase of 6 violations or 46.2 percent. Based on the rate of Attempt Capital Crime violations per 100,000 population, there has been an increase of 44.8 percent.

368 **Sexual Violations** were reported in the first six months of 2021, compared to 298 during the corresponding period in 2020. This represents an increase of 70 violations or 23.5 percent. Based on the rate of Sexual Violations per 100,000 population, there has been an increase of 22.3 percent.

19 **Commodification of Sexual Activity** violations were reported in the first six months of 2021, compared to 15 during the corresponding period of 2020. This represents an increase of 4 violations or 26.7 percent. Based on the rate of Commodification of Sexual Activity per 100,000 population, there has been an increase of 25.5 percent.

2,098 **Assault** violations were reported in the first six months of 2021, compared to 2,110 during the corresponding period in 2020. This represents a decrease of 12 violations or 0.6 percent. Based on the rate of Assault violations per 100,000 population, there has been a decrease of 1.5 percent.

85 **Violations of Deprivation of Freedom** were reported in the first six months of 2021, compared to 91 during the corresponding period in 2020. This represents a decrease of 6 violations or 6.6 percent. Based on the rate of Violations Deprivation Freedom violations per 100,000 population, there has been a decrease of 7.5 percent.

1,890 **Other Violent Violations (including Robbery)** were reported in the first six months of 2021, compared to 1,619 during the corresponding period in 2020. This represents an increase of 271 violations or 16.7 percent. Based on the rate of Other Violent Violations per 100,000 population, there has been an increase of 15.6 percent.

CRIMES AGAINST PROPERTY

10,299 **Crimes Against Property** (property crime) violations were reported in the first six months of 2021, compared to 10,534 during the corresponding period in 2020. This represents a decrease of 235 violations or 2.2 percent. Based on the rate of Crime Against Property per 100,000 population, there has been a decrease of 3.2 percent.

616 **Break & Enter** violations were reported in the first six months of 2021, compared to 857 during the corresponding period in 2020. This represents a decrease of 241 violations or 28.1 percent. Based on the rate of Break & Enter per 100,000 population, there has been a decrease of 28.8 percent.

961 **Theft Over \$5,000** violations were reported in the first six months of 2021, compared to 832 during the corresponding period in 2020. This represents an increase of 129 violations or 15.5 percent. Based on the rate of Theft Over \$5,000 per 100,000 population, there has been an increase of 14.4 percent.

4,067 **Theft Under \$5000** violations were reported in the first six months of 2021, compared to 4,003 during the corresponding period in 2020. This represents an increase of 64 violations or 1.6 percent. Based on the rate of Theft Under \$5000 per 100,000 population, there has been an increase of 0.6 percent.

683 **Have Stolen Goods** violations were reported in the first six months of 2021, compared to 735 during the corresponding period in 2020. This represents a decrease of 52 violations or 7.1 percent. Based on the rate of Have Stolen Goods per 100,000 population, there has been a decrease of 8.0 percent.

2,485 **Fraud** violations were reported in the first six months of 2021, compared to 2,642 during the corresponding period in 2020. This represents a decrease of 157 violations or 5.9 percent. Based on the rate of Fraud per 100,000 population, there has been a decrease of 6.8 percent.

1,450 **Mischief** violations were reported in the first six months of 2021, compared to 1,419 during the corresponding period in 2020. This represents an increase of 31 violations or 2.2 percent. Based on the rate of Mischief per 100,000 population, there has been an increase of 1.2 percent.

OTHER CRIMINAL CODE

2,373 **Other Criminal Code** violations were reported in the first six months of 2021, compared to 2,376 during the corresponding period in 2020. This represents a decrease of 3 violations or 0.1 percent. Based on the rate of Other Criminal Code violations per 100,000 population, there has been a decrease of 1.1 percent.

WEAPONS VIOLATIONS

215 **Weapons** violations were reported in the first six months of 2021, compared to 263 during the corresponding period in 2020. This represents a decrease of 48 violations or 18.3 percent. Based on the rate of Weapons violations per 100,000 population, there has been a decrease of 19.0 percent.

FEDERAL VIOLATIONS

922 **Drug Violations** were reported in the first six months of 2021, compared to 729 during the corresponding period in 2020. This represents an increase of 193 violations or 26.5 percent.

Based on the rate of Drug violations per 100,000 population, there has been an increase of 25.3 percent.

37 **Other Federal Violations** were reported in the first six months of 2021, compared to 44 during the corresponding period in 2020. This represents a decrease of 7 violations or 15.9 percent. Based on the rate of Other Federal Violations per 100,000 population, there has been a decrease of 16.7 percent.

TRAFFIC VIOLATIONS

1,924 **Criminal Traffic** violations were reported in the first six months of 2021, compared to 1,974 during the corresponding period in 2020. This represents a decrease of 50 violations or 2.5 percent. Based on the rate of Criminal Traffic violations per 100,000 population, there has been a decrease of 3.5 percent.

603 **Impaired Operation** violations were reported in the first six months of 2021, compared to 550 during the corresponding period in 2020. This represents an increase of 53 violations or 9.6 percent. Based on the rate of Impaired Operation violations per 100,000 population, there has been an increase of 8.6 percent.

320 **Dangerous Operation** violations were reported in the first six months of 2021, compared to 229 during the corresponding period in 2020. This represents an increase of 91 violations or 39.7 percent. Based on the rate of Dangerous Operation violations per 100,000 population, there has been an increase of 38.4 percent.

12 **Fatal Collisions** occurred on our roadways in the first six months of 2021, compared to 8 during the corresponding period in 2020. This represents an increase of 4 collisions or 50.0 percent.

13 **Persons Died** on our roadways in the first six months of 2021, compared to 9 during the corresponding period in 2020. Of those 13 dead in 2021, 8 were drivers and 5 were pedestrians.

CLEARANCE RATE

The **Clearance Rate** for Total Criminal and Federal Violations (excluding Traffic) decreased to 49.5 percent in the first six months of 2021 from 51.8 percent during the corresponding period in 2020. The clearance rate for Crimes Against Persons decreased 2.0 percent, for Property Crimes decreased 5.7 percent, for Other Criminal Code violations increased 2.1 percent, for Weapons violations increased 9.0 percent, for Drug violations increased 5.1 percent, and for Traffic violations increased 6.9 percent.

YOUTH CRIME

The **Youth Crime** rate per 1,000 youth population decreased to 3.22 or 34.7 percent in the first six months of 2021, compared to 4.94 in 2020. The number of youth involved in criminal incidents (formally charged and processed by other means) decreased to 331 or 32.3 percent in 2021 compared to 489 in 2020. The number of young persons charged decreased 45.1 percent and the number of youth processed by other means decreased 24.6 percent.
