#### 361 INDIGENOUS LAND ACKNOWLEDGMENT

"On behalf of the Board, we acknowledge that York Region is located on the traditional territory of many Indigenous peoples including the Anishinaabeg, Haudenosaunee, Huron-Wendat and Métis peoples and the treaty territories of the Haudenosaunee, Mississaugas of the Credit First Nation and Williams Treaties First Nations.

Today this area is home to many diverse Indigenous Peoples, and we recognize their history, spirituality, culture and stewardship of this land. We also acknowledge the Chippewas of Georgina Island First Nation as our closest First Nation community."

## 365 **2023 Operating and Capital Budget Overview – Chief of Police**

The Board received a presentation on the 2023 Operating and Capital Budget Overview. The Police Services Board approved the 2023 net Operating Budget for York Regional Police of \$391.5 million, which is a 3.9 percent increase over the 2022 Budget and includes the addition of 41 staff phased in over four years to support safer communities, organizational transformation and to combat serious and violent crimes. The 2023 Police Operating Budget continues to maintain the lowest policing cost per capita in Canada among comparable police services serving populations of over 1 million residents.

The Board also approved the 2023 York Regional Police Capital Budget of \$32.6 million. The 2023 capital expenditures include \$8.7 million for information technology, \$11.7 million for vehicles, \$2.5 million for communication equipment, \$5.4 million for facilities

primarily for the completion of #1 District Headquarters and \$4.3 million for specialized equipment. Financing for the capital budget is a combination of contributions from reserves, debenture proceeds repaid from development charges, debt reduction reserve funding, development charge collections and external funding.

The 2023 Police Budget will be tabled at Committee of the Whole in January 2023.

It was moved by Vice Chair Pellegrini, seconded by Mr. Perchal that the Board receive the presentation.

## 373 Update – Supreme Court Decision – Chief of Police

The Board received an update from the Chief of Police on the recent decision of the Supreme Court of Canada relating to Project Raphael, which dates back to 2014. The investigation targeted offenders of sex trafficking and child exploitation resulting in 104 arrests using undercover police techniques. The Supreme Court of Canada concluded that Project Raphael was a bona fide inquiry that did not amount to entrapment under the law.

There was an eighty-one percent conviction rate with 13 investigators on the case and sentences ranging from six months to two years.
