## Schedule of Conferences, Training and CAPG Webinars in 2023

#### 1. Recommendation

That the Board receive this report for information.

# 2. Summary

The York Regional Police Services Board recognizes the importance of ongoing training and education for its board members and board staff as outlined in its policies, specifically the Board Training and Orientation Policy No. 03/01. The Board acknowledges that members bring a variety of competencies and skills to their position on the Board and that their contributions can be enhanced through ongoing professional development opportunities. It is the policy of the Board to provide ongoing education and training to Board members.

## 3. Analysis

Newly appointed members of the York Regional Police Services Board are required to attend orientation sessions provided by the Executive Director in coordination with the Chief of Police. Members are also required to participate in any training programs provided by the Solicitor General; however, at this time, the Ministry does not provide mandatory training for police services board members.

Members can attend annual conferences of the Ontario Association of Police Services Boards (OAPSB) and the Canadian Association of Police Governance (CAPG) as well as any other training and development opportunities deemed appropriate by the Board.

It is recommended that at the first meeting of each year, a list of upcoming conferences, webinars and training opportunities be circulated to the Board members.

#### 4. Financial

Funds for training and conference attendance have been allocated in the 2023 board budget.

#### **Conclusion**

Appendix A outlines a list of the conferences, training and webinars in 2023 that might be of interest to the board members. Detailed conference information will be distributed as it is received and Board members will be canvassed at that time on whether they are able to attend. Attendance at the conferences will be subject to availability of funds in the 2023 conference budget.

This report sets out clear expectations for Board members with regards to comprehensive training opportunities which will provide enhancement and professional development for its members and board staff and will assist the Board in meeting its legislative obligations in fulfilling its governance duties.
